## Pearl Jam Presents "Home Run Hitting Contest" Official Rules

## NO PURCHASE NECESSARY.

The Pearl Jam Presents "Home Run Hitting Contest" ("Contest") begins at 10:00:00 AM Eastern Time ("ET") on 11/21/2017 and ends at 3:00:00 PM ET on 1/15/18 ("Contest Play Period").

**SPONSOR:** Republic Records, a division of UMG Recordings, Inc., 1755 Broadway, New York, NY 10019 ("Sponsor") is responsible for all aspects of this Contest.

**ELIGIBILITY:** Contest is open to legal residents of the 50 United States (including the District of Columbia) age 13 or older at time of entry. Employees of Republic Records, a division of UMG Recordings, Inc. (the "Sponsor"), Pearl Jam (the "Artist"), and their respective parent companies, affiliates, subsidiaries, agents, advertising and promotions agencies, and any other individual or company involved in the development or execution of the Contest ("Released Parties") and their immediate families (parents, siblings, children and their respective spouses) and same households of each, whether or not related are not eligible to play or win. No groups, clubs or organizations may participate in this Contest or reproduce or distribute any portion of these official rules ("Official Rules") to its members. HOW TO PLAY: Follow the on-screen instructions at <a href="http://8bitbaseball.pearljam.com/">http://8bitbaseball.pearljam.com/</a> (the "Website") to select a virtual member of Pearl Jam as your character, press "Start", and using the space bar on your computer to swing the bat; accumulate points equivalent to the distance of each home run ("Task") achieved within sixty (60) seconds. Upon completion of the sixty (60) seconds of play, follow the on-screen instructions to submit your score in order to track and accumulate points via the Contest leaderboard. Points will be awarded in various denominations based upon the total accumulation of distance reached per Task. Players will have the opportunity to earn a minimum of three hundred and twenty (320) points and up to a maximum of six thousand four hundred and ninety-two (6492) points per additional Task executed. During the sixty (60) seconds of play, each player who completes two (2) Tasks with a distance greater than four hundred and forty (440) feet will receive a bonus thirty (30) seconds of play. Points awarded per Task(s) are subject to change at Sponsor's sole discretion. Points earned are subject to all notices posted online including Sponsor's privacy policies. Multiple players are not permitted to share the same email address. Sponsor is not responsible for any typographical, printing, or other errors; or for game plays that are late, incomplete or delayed and/or for points that are: lost, misdirected, stolen, garbled, undelivered, or any combination thereof. All requests and/or materials submitted become the property of the Sponsor and will not be returned or acknowledged.

**WINNER DETERMINATION:** At the conclusion of the Contest Play Period, the player with the greatest number of points will be declared the winner. In the event of a tie among players, the player that obtained the tied score first will be declared the winner. In the event of a further tie, the winner will be determined based on which player enrolled to participate in the game. Sponsor's decisions are final in all matters relating to the Contest.

**PRIZE:** The top scoring player will receive one (1) official Cubs baseball autographed by the members of Pearl Jam and one (1) custom Pearl Jam baseball bat. If winner cannot accept the prize for any reason, or if he/she is not in compliance with the Official Rules, such winner will be disqualified and the corresponding prize may be awarded to the player with the next highest score on the leaderboard. Approximate retail value ("ARV") of prize: \$200.00. Arrangements for the fulfillment of any prize will be made by Sponsor and/or its designated agent. No substitution of prize offered, no transfer of prize to a third party is permitted and prize may not be redeemed for cash value,

except by Sponsor, who reserves the right in its sole discretion to substitute prize. All taxes or other expenses relating to the use, acceptance and possession of prize are the sole responsibility of winner.

WINNER NOTIFICATION: Winner must be able to receive calls from an unlisted/blocked number. The contact information provided at time of registering to play the Contest will be used to notify winner. Winner may be required to complete and return an Affidavit of Eligibility and Liability and, unless prohibited by law, Publicity Release ("Affidavit/Release") as well as any other documents ("Prize Notification Documents") within five (5) days of date specified on notification, or he/she may be disqualified. Sponsor, in their sole discretion, reserves the right to disqualify any player who engages in any conduct the Sponsor deems to be improper, unfair or otherwise adverse to the operation of the Contest.
